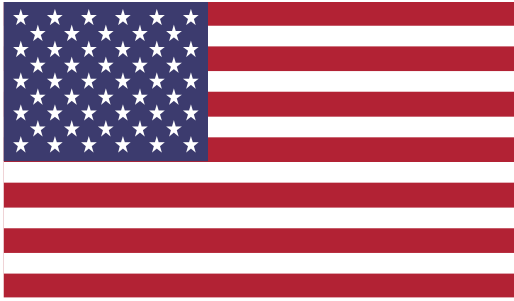

Red Creek Mining is structured like club with members rather than a business with owners and employees. Every member is treated as an equal and we all share expenses for equipment, housing, food, fuel, etc paid for with revenue from the gold we recover. We have no employees or outside investors - every member gets a share in the gold revenue of the mining season after expenses. In our most recent season - Summer 2019 each member took home a base share of \$391,858 each after expenses.

The gold mining season lasts from late May through the end of September approximately (120 days). Always dependent on the changing seasons and weather. We need members to commit to staying the full 120 days without interruption or trips away.

**ZERO TOLERANCE DRUG POLICY**

I understand that Red Creek Mining enforces a "ZERO TOLERANCE POLICY" which strictly enforces the prohibition of illegal drugs (narcotics, marijuana, stimulants or other similar controlled substances) on our mining locations. ## **TRANSPORTATION TO YUKON/ALASKA**

Each individual member is responsible for their flight to Alaska or the Yukon. (\$300 - \$500 average for one way flights) Do not book your flight until you have been assigned a definite start date in April.

## **OBTAINING A U.S. PASSPORT**

If you are a U.S. Citizen that will be working in Canada, you will need a U.S. Passport. The cost is \$145 and takes 6-8 weeks to process, or 2 weeks if expedited. Red Creek Mining can not do this for you. The application process and documents needed are explained in detail at the link below.

## **CANADIAN WORK PERMIT**

If you are a U.S. Citizen that will be working in Canada, you will also need a Canadian work permit to work on the mining claim. Your cost is \$388 each year and this permit takes 4-8 weeks to obtain.

Red Creek Mining is your sponsor and handles the application process, if you are accepted as a new member.
